TERMS AND CONDITIONS

Please tick to indicate you have read and understand the following statements.

 \Box Pets with any ongoing or past injuries/health issues require a signed consent/release form from your veterinarian prior to use of the underwater treadmill or rehabilitation facilities.

 \Box Pets must be current on all required vaccinations.

 \Box Pets are not permitted to use the underwater treadmill if they have diarrhoea, infectious or contagious conditions like eye or skin infections, in order to prevent harm to both your pet and other clients pets. If you need to cancel your appointment, 24hrs notice is required otherwise we reserve the right to charge the usual fee associated with the service.

 \Box Please ensure your pet has been walked and has urinated/defecated prior to use of the underwater treadmill. Accidental elimination in the underwater treadmill will incur a \$50 surcharge to cover the cost of the treadmill being shutdown for cleaning, disinfection, and maintenance.

 \Box We request that your pet is not fed for 2-3hrs prior to use of the underwater treadmill (treats are allowed). This reduces the chance of both elimination while in the underwater treadmill, and injury to the pet.

 \Box All pets must be relatively clean and have well trimmed nails prior to entering the underwater treadmill. If necessary, a nail trim can be performed by our staff for the standard fee.

 \Box At the end of your pet's session in the underwater treadmill, we will towel dry your pet. You may wish to bring additional towels for your vehicle and a jacket for your pet during the colder months.

 \Box I understand that Grand Valley Animal Clinic reserves the right to take pictures or video recordings of my pet for advertising, publicity or other business purposes.

 \Box I give permission to Grand Valley Animal Clinic to share client information with my regular veterinarian in order to provide services to my pet.

□ Grand Valley Animal Clinic reserves the right to deny or refuse use of the underwater treadmill or rehabilitation facilities to any pet or its owner, including but not limited to: safety issue with other pets/employees, evidence of people/pet aggression and evidence of infectious or contagious disease.

 \Box I understand that all payments are due at the time of service.

Grand Valley Animal Clinic is not responsible for missed or cancelled sessions. Any sessions cancelled with less than 24hrs notice, or missed sessions, will be charged the usual fee associated with the service.

Unused sessions on a pre-purchased package are NOT refundable.

IMPORTANT INFORMATION

Certain conditions require precautions or are contra-indicated for use of the underwater treadmill and other rehabilitation modalities such as laser therapy and therapeutic exercise activities. These can include, but are not limited to, active bleeding/hemorrhage, infectious or contagious diseases, cardiac or respiratory disease, epilepsy, open/draining wounds, incisions, severe obesity and non-stable fractures.

Use of the rehabilitation facility and its modalities is **NOT** intended to be a replacement for primary veterinary care.

Veterinary confirmation of good health is required for recreational/fitness use of the facility.

A veterinary referral is required for any pets that have medical conditions, or are recovering from a veterinary procedure, where rehabilitation would be beneficial. We will provide updates and progress reports to the referring veterinarian if requested.

I understand and recognize the inherent risk of injury to pets and their owners associated with

participation in the various activities associated with use of the facility, including therapeutic exercise and use of the underwater treadmill. I also realize pets are capable of, and given to, independent action. I accept and acknowledge that Grand Valley Animal Clinic is not responsible for any injury, damage or loss resulting from, or connected in any way to use of the facility.

I acknowledge that I have read, understood and accept the risk associated with use of the facility.

I agree to fully release and forever discharge Grand Valley Animal Clinic, its agents and employees, from any and all claims for loss, damage or injury to my pets while in the care, or on the premises, of Grand Valley Animal Clinic. This encompasses participation in any and all services or activities, including, but not limited to, use of the underwater treadmill and therapeutic exercises.
